- 1.** In order to pre-register you must fill out this "ADDENDUM TO BIDDERS AGREEMENT" and furnish an active telephone line or electronic messaging address (provide this information below) to be used at time of the auction. All funds for this transaction shall be in U.S. dollars.
- 2.** Prior to auction date, you must furnish the above referenced deposit payable to **American Heritage Auctioneers, LLC, Trust Account via the following methods.** **1) Wire Transfer:** When we receive these executed documents, we will contact you with our wire instructions. **2) Personal or Business Check:** Your Personal or Business Check will be not be deposited unless you are the winning bidder.
